AMSTERDAM, July 14, 2023 - Stellantis N.V. ("Stellantis" or the "Company") announced today that pursuant to its Second Tranche of the Share Buyback Program announced on June 7, 2023, covering up to €500 million to be executed in the open market during the period between June 7, 2023 and September 7, 2023, it has repurchased the following common shares in the period between July 7 up to and including July 13, 2023:
